Target group:	 Asylum-seekers who do <u>not</u> come from safe countries of origin. On application, they can have access to integration courses and if necessary also to occupational language courses according to §45 AufenthG and the German language promotion ordinance. If they have good prospects of obtaining long-term residence or if they arrived before 01.08.2019 (after the prohibition period has expired), if they fulfil one of the following conditions: Persons who are available to the job market are: registered with the Agentur für Arbeit (job centre) as looking for training, work or out of work, who are employed or in company-based training as well as in an entry qualification, in a vocational preparation training measure or the preparatory training phase of assisted training. Tolerated persons, who are <u>not</u> subject to an employment ban in respect of entitlement to remain, will be given wider access to the occupational language course. They can receive a certificate of participation: in the case of toleration according to. § 60a para. 2 clause 3 AufenthG (fundamentally from language level B 1) or after six months tolerated stay, if they are <u>available to the job market</u> (important: also access to occupational language courses under the B 1 level). Asylum-seekers who are bringing up children who are not yet of school age do not have to fulfil the criterion of being available to the job market in order to receive access to federally sponsored language development.

	 Persons from safe countries of origin still do not have access to the federal integration measures while their asylum process is ongoing. The Agentur für Arbeit issues the necessary certificate with which they can get access to the relevant language courses. The approval application for participation in an integration course should be made to the Bundesamt für Migration und Flüchtlinge (BAMF). As evidence of having registered for support from the Agentur für Arbeit, the persons eligible for access require meaningful documentation. This could be: Confirmation of the existing unemployed status or registration as looking for work or training through the Agentur für Arbeit Certificate about unemployment benefit (Arbeitslosengeld) Confirmation from the provider about ongoing support (preparing for work, preparing for training phase of the assisted training) Work or training contract together with the presentation of the residence documents which the employment by the relevant employer allows. 	
Other:	 The relevant careers advisers decide, as before, on the participation in occupational language courses according to the German language promotion ordinance of the Agentur for Arbeit. Participation and travel costs vary according to target group. Courses with a final examination (telc)
